The Managing Trustee, St. Peter's Institute of Higher Education and Research, St. Peter's University, Avadi, Chennai has applied for establishment of a Medical College at Hosur, Krishnagiri District. On careful consideration of the proposal, the Government of Tamil Nadu have decided to issue an Essentiality Certificate to the applicant for the establishment of a new Medical College in the name and style as "St. Peter's Medical College Hospital and Research Institute", with an annual intake of 150 seats subject to the following conditions before Medical Council of India inspection:-

- a. To produce and comply with of Fire Safety certificate before the MCI inspection.
- b. To fulfill and comply with shortage of infrastructural facilities, Building Completion Certificate , Building Stability Certificate and Tamil Nadu Pollution Control Board clearance Certificate well before the MCI Inspection.
- c. To fulfill and comply with the deficiencies pointed out by the Government before the MCI inspection without-fail.
- d. To equip 100% faculties, clinical and non clinical departments before the MCI inspection without-fail.

Further bank guarantees specified by Medical Council of India for the establishment of teaching hospital to be handed over to the Medical Council of India, New Delhi and stability certificate of the hospital building obtained from the competent authority should be submitted to the Medical Council of India while making inspection and also rectification of deficiencies pointed out by the Inspection Officers before the Medical Council of India inspection and the approval of Medical Council of India/Government of India should be obtained.

It is certified that:-

- a. The applicant owns and manages a 300 bedded functional Hospital which was established in the campus of the proposed location.
- b. It is desirable and feasible to establish a Medical College in the Public interest
- c. Establishment of a medical college at Hosur, Krishnagiri District by the Managing Trustee, St. Peter's Institute of Higher Education and Research Institute is feasible.


- d. Adequate Clinical Material as per the Medical Council of India norms is available.

It is further certified that in case the applicant fails to create infrastructure for the Medical College as per Medical Council of India norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of students already admitted in the College with the permission of the Central Government.

The following shall be added in terms of Notification dated 31.01.2017 published in the Gazette of India :-

- e. The Managing Director own and possesses 31.82 acres of land in Hosur, Krishnagiri District on which non-agricultural use of land is permitted and a Medical College/ Hospital can be established on it. (vide Certificate of Tahsildar, Hosur Roc. No.1712/ 2020 / A2 dated 8.7.2020)
- f. The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Special Officer /Block Development Officer (as per delegations of powers given by the Member Secretary, Hosur new Town Development Authority, Hosur vide Na. ka. No 16394/2017/ sibi dt 19.10.2017 and Na. ka. No 1127/2017/ opunavaku dt 28.12.2017) for such purposes on 08.01.2018 vide Na.Ka. No. 21/ 2017/ Perandapalli Panchayath
- g. The Hospital and Medical College have been granted Completion / Building Use Certificate by the competent authority, namely Tahsildar, Hosur designated by the Government for such purpose on 18.10.2019 vide K. Dis. No 4854/ 2019(A1)
